- Installation of sustainable filter systems to purify contaminated water.
- Construction and maintenance of sanitation facilities to improve hygiene and public health.
- 2. Food security and agricultural support
- Setting up vegetable gardens and agricultural projects with local communities.
- Training in sustainable agricultural techniques, such as drought-resistant cultivation and composting.
- Distribution of seeds, tools, and fertilizers to farming families.
- 3. Health and hygiene
- Organizing medical missions and health campaigns.
- Providing information on hygiene, nutrition, and disease prevention.
- Collaboration with local health centers to improve healthcare infrastructure.
- 4. Education and capacity building
- Building or renovating schools and classrooms.
- Supplying teaching materials, school uniforms, and scholarships for disadvantaged children.

Expenses incurred by the board and volunteers will be reimbursed to the extent that this is reasonable and can be justified by them. The foundation does not provide any financial compensation for volunteer hours.
